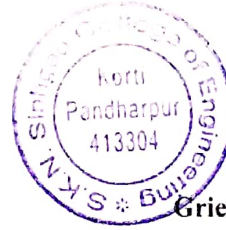

### Minutes of Meeting of Grievance Redressal Committee



The meeting of Grievance Redressal Committee was held on 14/07/2022 at 3.00 PM in the bedroom. The following are the minutes of the meeting.
